2. Approval of minutes (Appendix A)

2.1. No changes, Approved unanimously at 12:46pm

3. Annual Report from Dean Agouris

- 3.1. Where are we this year?
 - 3.1.1. Growth of about 5% this year, significant growth (18%) in first-time freshmen
 - 3.1.2. Productive year graduate admissions, 5% growth in PhD, 4% in Masters
 - 3.1.3. Noticeable growth in research funding, still more post-docs and research faculty than any other college
- 3.2. Diversity
 - 3.2.1. Almost 60% female students
 - 3.2.2. More than 60% female/minorities in our college leadership team
- 3.3. Annual meeting with provost was positive
 - 3.3.1. Figuring out ways to leverage budget model to our advantage
- 3.4. Some changes to equipment fund in coming years, ~\$1.6 million
 - 3.4.1. Annual awards, typically \$800K/year
 - 3.4.2. Calls for proposals will go out in early Spring semester, for purchases to be made by end of term
 - 3.4.3. All will go through the COS Budget and Planning Committee
- 3.5. Open Door Sessions (question from Barney Bishop)
 - 3.5.1. At Fairfax (Exploratory Hall 3200) and SciTech campus (IABR 3006)
 - 3.5.2. All COS officials also holding hours for faculty walk-in sessions at SciTech
- 3.6. Question from Gerald Weatherspoon: Power requirements in older buildings is not adequate for modern research. What can be done?
 - 3.6.1. COS is absorbing this cost, "we are doing all we can at a cost of several hundreds of thousands of dollars"
 - 3.6.2. Martha: we are working to get space functional now, also communicating with facilities about larger issues regarding power capacity and infrastructure projects to address these issues.

- 3.6.2.1. We've added a Facilities section to the budget request forms for new faculty hires to try to "get a jump" on facilities issues in advance of hiring.
- 3.6.3. We should also be including facilities and personnel costs in all requests.
- 3.7. Question from Peter (Physics)
 - 3.7.1. Would it appropriate to have an ad-hoc committee about space requirements?
 - 3.7.1.1. There is already a COS Space Committee, but Facilities itself is a real issue, overquotes and delays are common
 - 3.7.1.2. Space itself is also being taken away and isn't clearly allocated. Makes planning long term very difficult. We are working to manage what we can control.
 - 3.7.2. What is going on with hiring this year?
 - 3.7.2.1. Planning is done at the department level. Exception is new research centers or initiatives
 - 3.7.2.2. Last year we hired 15 tenure-track faculty positions, 3 term, and 4 admin
 - 3.7.3. Could have full programs relocated to SciTech campus (at the request of Central Administration)
 - 3.7.4. Look for growth
- 3.8. What are the top priorities for the college? (Peter)
 - 3.8.1. We want to take care of our people, give them resources they need to be successful, including start-up funds and space
 - 3.8.2. Empowered, appreciated, and engaged faculty and staff
 - 3.8.3. We are focused on education. Our priority is our studnets. The college wants to support faculty so that they can be successful in their jobs.
