- 4. Dean's Update (Fernando)
 - 4.1. Inclusive Excellence plan for COS
 - 4.1.1. More information in a meeting on 04/21/2021
 - 4.2. Vaccination mandate for Fall 2021
 - 4.2.1. Some other public universities have already imposed a mandate
 - 4.2.2. Discussion with other deans led to asking faculty for their input. What does faculty think about the idea of imposing a vaccine mandate? Fernando is leaning towards a mandate, as having vaccines voluntarily may keep things to lose. This poll is to measure the temperature among faculty: What do we think about imposing a mandate?
 - 4.2.3. Rebecca Jones: We have prepared two pools, one regarding a mandate for students / one for faculty.
 - 4.3. University Target: 75% of classes offered in some form of face to face in Fall 2021.
 - 4.3.1. Current numbers: Within 1% of 75%. => We're on a good way
 - 4.3.2. Fall 2021 will look much different from Spring 2021. Fall 2021 will look more normal. Normal as in Fall 2019.
 - 4.3.3. This 75% normality issue is coupled with the vaccination issue. If we want such a high presence on the campus, we need to maintain a feeling of safety.
 - 4.3.4. Q: Ernie Barreto: 75% of classes or 75% of seats? A: Fernando: Not clear yet. Likely seats. But this number is just an orientation. Noone will be penalized if not meeting these numbers.
 - 4.3.5. Q: Some classes may not have rooms? How are these handled. A: Fernando: There will be questions and that will be ok. The 75% is a target not a requirement. It's more of an estimate. This number is not "sacred".

- 4.3.6. Poll 1: Mason is considering a COVID-19 vaccine mandate for students to return to campus for classes in Fall 2021. What is your opinion on this topic?

- 6. Update on Faculty Handbook revisions, Suzanne Slayden
 - 6.1. Main intent of revisions: Incorporate term faculty entirely, instead of having a separate section on term faculty.
 - 6.2. Existing language that was purely for term faculty was redistributed across other sections
 - 6.3. Including input from the term faculty task force
 - 6.4. In addition: Revision of some language about tenure-line faculty
 - 6.5. Summary of revisions: <u>https://www.gmu.edu/resources/facstaff/senate/FacultyHandbook/fac-hndbk-rev-</u>2021.htm
 - 6.5.1. Also has a link to the current faculty handbook
 - 6.6. Added: Rules for voting
 - 6.7. Added: Rules for evaluation to meet standards of local academic units as defined in bylows of departments. Departments: Make sure you have updated bylaws. (tenure line and term)
 - 6.8. Change in study leave: No longer administered by Provost. Money still comes from the provost, but administration at college level. Handbook adjusted accordingly.
 - 6.9. Revision committee had representatives from term and tenure-line, as well as senate representatives.
 - 6.10. If approved will go into effect July 1st.
 - 6.11. Q: Tim Leslie: Would change in the handbook overrule items in department bylaws? A: Suzanne: Language tends to be written in a way that is flexible for individual units.
 - 6.12. Q (Tim Leslie): What is a department disfranchises Term Faculty? A: Ask your department why? Term don't have to vote on everything, for example, not on tenuring tenure line faculty. But topics related to term faculty should be included.
 - 6.13. Q (Tim Leslie): GGS currently has that in their bylaws: A: There will be pressure to change that.
 - 6.14. Q (Ben Dreyfus): Can we start using the new titles ("Instructional" instead of "Term") now, or do we have to wait until it formally goes into effect? A: Nobody is forcing the use of the term "Term". HR will use the formal title "Instructional Assistant Professor" in all official matters. For your own title, you can use anything you like as long is it does not inflate your position.

- 7. Update regarding research spaces and Facilities, Pat Gillevet and Carrie McVicker
 - 7.1. Pat and Carrie not present. Will loop back next meeting.
 - 7.2. Andreas Züfle provided a brief overview of the discussions so far:
 - 7.2.1. Background: The presidents office is following up with issues that were raised by COS faculty during President Washington's Virtual Academic Unit Visit to COS (Oct 13, 2020). These issues were:
 - 7.2.1.1. "Research space is lacking and physical classrooms are crowded. What is being done to strategically grow our physical footprint and advance our research and teaching missions?"
 - 7.2.1.2. "Space renovations for research labs are being charged to PIs at exorbitant prices. Our facilities department has no apparent accountability or competition for these services. How can this be addressed going forward?"
 - 7.2.2. Pat Gillevet and Carrie McVicker are working with the VPR's office and Facilities about issues like these.
 - 7.2.3. Faculty have reported great experience working with Carrie
 - 7.2.4. Pat and Carrie will provide faculty information on how to address room/renovation issues (such as requiring a specific cable connection) to avoid hickups and delays.
