# **COURSE DESCRIPTION (3 credits)**

This course provides an overview of the subfield of human geography called political geography. Subtopics surveyed include traditional areas of focus for the subfield, including electoral geography and state formation, in addition to themes that political geography has taken up since its foundation, including social movements, environmental injustice, etc. Theory foundational to political geography in addition to an array of other social sciences will be discussed alongside historical and contemporary case studies. Special attention is paid to the unevenness of power at various scales as expressed through Politics/politics.



# PARTICIPATION (100 pts, 10%)

For this class, participation means that you show up and when you show up, you're actively engaged with me and your classmates, contributing verbally and non-verbally. If you struggle speaking in class, I hope you find this class comfortable enough to use it as an opportunity to practice AND also take advantage of contributing during partner and/or small group work.

# **READING RESPONSES (100 pts, 10%)**

You must complete 5 Reading Responses (RR) (there are 10 opportunities to complete responses), which are one paragraph (at least 150 words) double spaced where you summarize the key content and argument of one scholarly reading assigned for the week. When you can make connections between readings/topics than span units and/or relate to outside events, do so. You do <u>NOT</u> need to include a works cited page. At least 2 RR must be completed prior to Spring Break,

# REFLECTION (100 pts, 10%)

At the end of the semester, you are responsible for writing a 2 page (500 words), double spaced, reflection about yourself and the course.

## ASSIGNMENTS (700 pts. 70%)

You will complete 4 assignments throughout the course of the semester pertaining to the 4 units/themes of the course. You will have some time in class to work on these with classmates and brainstorm/get feedback. Format of assignments is variable and may include writing, creating visuals, recording a "podcast," conducting observation and interviews, creating an annotated map, etc.

# **ASSIGNMENT PROCEDURES**

<u>All assignments must be submitted on BB.</u> Save written assignments as <u>word documents</u> and upload to BB.

You are responsible for proper and timely submission. If you have a technical issue and cannot submit via BB, you MUST email a copy of the assignment to the professor <u>before</u> it is due in order to receive credit. Please avoid having to do this by submitting to BB before the last minute.

For RR, you will have two submission opportunities. This is so that you can submit your work once and view the University's plagiarism checker SafeAssign report; then you can correct anything that may be flagged and resubmit. The most recent submission is what will be graded. You are strongly encouraged to view the SafeAssign report and make corrections, as plagiarism is treated seriously in compliance with university policy (see Academic Integrity section).

## LATE WORK POLICY

Each student starts with 2 late work tokens, which allow you to turn in a graded item up to 48 hours past the original due date without penalty. When using a late token, you do NOT need to email the professor in advance; simply turn in/complete your item on BB as usual.

#### Examples:

If something is due to BB on Tuesday at 12:00 pm and:

- You turn it in on Weds 10:46 am, I will mark down that you used a late token; no penalty
- You turn it in on Fri 7:13 am, no credit offered because turned in after 48 hr extension

If you need an extension due to extenuating circumstances that are recognized by the university, it is your responsibility to contact the professor by email to inquire about an extension *prior to the original due date; this does not guarantee an extension.* 

If you do not use one or both late tokens, extra credit is applied.


