COURSE DESCRIPTION (3 credits)

This course provides an overview of the major branch of geography called human geography. The study of human geography investigates how people and human activities are connected to and interact with place, space, and landscape. Questions asked by human geographers include: How does place influence people? How do people influence place? What are the effects of global processes at the local level, or scale? How is human activity—agricultural practices, internet use, industrialization, etc.—spatially distributed? Why do certain patterns of human activity exist on the landscape in the way that they do? Human geographers are committed to understanding the spatial distribution of human activity and humans' relationships with place in order to identify, interrogate, and reduce social inequalities.

7. Demonstrate awareness of changes in social and cultural constructs

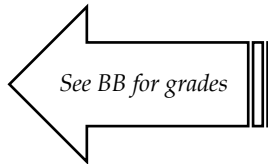
EXPECTATIONS FOR BEING AN ONLINE STUDENT

DISCUSSIONS (150 pts, 15%)

You are required to complete 5 discussions over the course of the semester. See BB for prompts and rubric. You must make an initial post and respond to 1 classmate by the due date.

ASSIGNMENTS (400 pts, 40%)

You are required to complete 4 assignments over the course of the semester. See BB for directions and rubrics. See Assignment Procedures for SafeAssign explanation.

ASSIGNMENT PROCEDURES

All assignments must be submitted on BB. For assignments that don't prompt you to enter information directly into BB (like a quiz or survey form) or a BB text box, save assignments as word documents or PDFs and upload to BB.

You are responsible for proper and timely submission. If you have a technical issue and cannot submit via BB, you **MUST** email a copy of the assignment to the professor **before** it is due in order to receive credit. Avoid having to do this by submitting to BB before the last minute.

For writing-based assignments, you will have two submission opportunities so you can submit your work once and view the University's plagiarism checker SafeAssign report, make necessary corrections, and resubmit. The most recent submission is what will be graded. Plagiarism is treated seriously in compliance with university policy (see Academic Integrity).

***QUIZZES (300 pts, 30%)**

You are required to take 4 quizzes over the course of the semester. Quizzes occur at the end of each week and pertain to content covered in that week. Format will be a mix of multiple choice, T/F, fill in the blank, and short answer.

***FINAL EXAM (150 pts, 15%)**

There is one cumulative final exam for this course and covers material from all weeks. The format will mimic the format of the quizzes.

***NOTE:** Quizzes and the final exam are open resource, meaning you can use resources on the BB site, books, and notes to help you complete it, but you must abide by the GMU Honor Code

by completing it individually without collaborating with anyone in any way. See the Academic Integrity section.

LATE WORK POLICY

Each student starts with 4 late work tokens, which allow you to turn in a graded item up to 48 hours past the original due date without penalty. When using a late token, you do NOT need to email the professor in advance; simply turn in/complete your item on BB as usual. For discussions, you may use a late token on the initial post and/or the reply.

Examples:

If an assignment is due to BB on Thursday at 11:59 pm and:

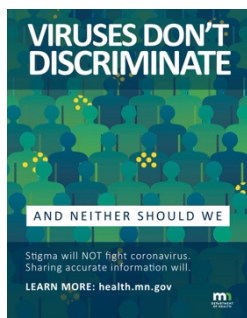
