Course Description

This 3-credit course activates or flexes your already-existing social justice mindset with a spatial perspective. Spatial Justice provides a set of theories to teach us how to critically interrogate unequal distribution of various environmental and social resources, resulting in patterns of social inequality. We consider what can be done to disrupt processes and discourses that have led to spatial injustices in the first place. Geographers and non-geographers are welcome. The course does not require, nor teach, technical skills; however, there is flexibility in course projects so that students may produce quantitative or qualitative analyses.

Required Texts

Readings are free and accessible on Blackboard (BB).

Learning Outcomes

- Define and identify spatial justice and injustice
- Explain theories of spatial justice
- Analyze sets of conditions that lead to injustices
- Evaluate impact of various ways to minimize or reverse spatial injustices
- Design and implement a plan of action to minimize or reverse an existing injustice

Participation

For this class, participation means that you show up and when you show up, you're actively engaged with me and your classmates, contributing verbally and non-verbally. Reading Responses

You must complete 4 Reading Responses (RR), which are one page (at least 300 words) double spaced where you summarize the key content and argument of an assigned scholarly reading. After each summary, you must also include 3 questions you have about the reading or that arose from the reading. You also must include a link to a news article that is somehow related to the scholarly reading topic and provide a few sentence explanation of the connection between the news article and the scholarly reading.

190 pts, 19%

Annotated Bibliography & Discussion Lead

You will lead a class discussion on an agreed-upon topic that profiles a spatial injustice. In order to prepare, you will create an annotated bibliography with 5 sources that relate to the topic. You will meet with the professor to go over your discussion lead plan and then execute it in class.

500 pts, 50%

Project

There is one major project in the course. It has several parts including: topic submission (50 pts), proposal (100 pts), preliminary report (50 pts), implementation and summary report (100 pts), presentation (200 pts). In a nutshell: you must identify a spatial injustice and take an action to disrupt or intervene into that injustice.
